# Information and Indemnity Form 2024

**Dear Parents,**

A warm welcome to the aftercare/homework center. We aim to provide a safe, stimulating, and homely environment for our children after school.

## **Information:**

- The aftercare program runs from **13h00 until 17h00 during the school term.**
- We assist and supervise their homework, guide them with their speeches/projects, and help them with exams/test preparation.
- We have a **holiday program** during the school holidays from **08h00 until 13h00 at our other Aftercare premises - 8 Morkel Street, Groenkol - no extra fees.** During the holiday program, we focus more on English, Afrikaans, and Maths.
- Children are collected by the **Hoekberg gate** at **13h30**. Children that are participating in sports or extramural activities will be collected by the **Main gate** at **15h00. No latecomers** will be tolerated.

- The children receive a **balanced meal** after school and snacks in the afternoon:
  - **Monday** - Spaghetti and mince
  - **Tuesday** - Rice, mince, and veggies
  - **Wednesday** - Macaroni and cheese
  - **Thursday** - Rice, mince, and veggies
  - **Friday** - Fun food: Hotdogs, waffles & ice cream, vetkoek, toasted ham/cheese
  - **Snack** - Fruit, biscuits, water/juice

- English and Afrikaans **Phonographix reading & spelling classes** for Gr. R - Gr. 7 and **Coding & Robotics classes** for Gr. R - Gr. 3 are available at an additional cost.
  - We have a **WhatsApp communication group**. This group informs us or the parents, of children that should not or are not collected at the school.
  - We are also using the WhatsApp group to inform the parents about the children's homework and additional information.

## Aftercare school fees policy:

- Aftercare fees are strictly payable in advance on or before the first day of the month.
- Aftercare fees are **R1 500.00 per month x 10 months** (February until November). Children may attend aftercare during school holidays. **This excludes 15/12/2025 until 06/01/2026.**
- A **registration fee of R500** is payable with registration - **annually**.
- **Accountability Solutions (Pty) Ltd** assists us with the recovery of outstanding monies. Please note that once the matter has been handed over to Accountability Solution, you will be liable for all legal and collection costs.
- Aftercare fees can be paid in cash, internet banking, or card facility at the school.
- **One calendar month's written notice** must be given should your child intend to leave the aftercare centre. Should you not give your notice in writing; you will be liable for the month's aftercare fee.
- Should your child be removed from school without notice or outstanding fees not be paid off, the account will be handed over to Accountability Solutions for collection at your cost.
- If aftercare fees are **not paid 3 days after** the agreed date of services, they will be suspended until full payment is made.
- Should your child be sick or not attending the aftercare centre for any reason, fees must be paid in full.

## Indemnity:

### Conditions (I the undersigned)

- The parents/legal guardians of the abovementioned child do hereby agree and accept that the teachers in charge of this aftercare will care for their child/ren to the best of their ability.
- The indemnity shall commence on the first day of attendance and shall cease and terminate on the last day of the child's attendance at the aftercare.
- I furthermore agree that my child has to obey all instructions given by the teachers at the aftercare center.
- I will be held responsible for any medical and hospital accounts that may occur.
- I give permission to staff to provide my child with First Aid Medical Treatment if needed.
- The collection of children is a bona fide service. Please ensure that your child/ren is informed about the collection time at the gate and after sports activities (Please see above).
- I hereby indemnify Pre School for Toddlers (Pty) Ltd. ("Aftercare Center") of the place of care in respect of any emergency, injury, or accident of whichever nature and whichever circumstances our child may acquire whilst he/she is under the control and care of Toddler's Academy Aftercare centre.
